## Notice

Call for Post-Doctoral Research Fellowship (BIPD)

The Nursing School of Coimbra (ESEnfC) is opening a call for 3 (three) Post-Doctoral Research Fellowships (BIPD) for the Health Sciences Research Unit: Nursing (UICISA: E), 1 (one) under project ref. UIDB/00742/2020 and 2 (two) under project ref. UIDP/00742/2020. The fellowships will be funded by national funds through FCT/MECI (PIDDAC) under the following conditions:

**Scientific fields:** Nursing, Health Sciences, Social Sciences, and allied fields.

**Grant recipient(s)/Admission requirements:** Candidates must hold a doctoral degree in the scientific fields mentioned above for at least three years. In accordance with paragraph 3(b) of Article 7 of the Regulation of Research Fellowships of the Foundation for Science and Technology (FCT), I.P., the research leading to the award of the doctoral degree must not have been carried out at UICISA: E.

**Preferred requirements**: A high level of knowledge in scientific research methodologies. Experience in research activities. A high level of proficiency in written and spoken English.

If the qualifications have been conferred by a foreign higher education institution, they must be recognized by a Portuguese higher education institution, in accordance with Decree-Law No. 66/2018, published in *Diário da República*, 1st series, No. 157, of 16 August, and any formalities established therein must be fulfilled by the application deadline.

## Areas of knowledge to be developed and Scientific Orientation:

- 1 Study and development of a device to prevent needlestick injuries and the risk of contamination in nursing practices, under the supervision of Professor Pedro Miguel Santos Dinis Parreira.
- 2 Person-Centered Care: from conceptual models to implementation, under the supervision of researcher Filipa Isabel Quaresma Santos Ventura.
- 3 To carry out research activities in the Research Unit as part of the integrated action project for the development of the Research Unit, under the supervision of Professor João Luís Alves Apóstolo.

**Applicable legislation and regulations**: The Research Grant will be awarded in accordance with the Research Grant Holder Statute (Law no. 40/2004 of 18 August and Decree-Law no. 123/2019 of 28 August) and the Legislation and Regulation of Research Fellowships of FCT, I.P in force, Regulation no. 950/2019 of 16 December 2019 <a href="https://files.diariodarepublica.pt/2s/2019/12/241000000/0009100105.pdf">https://files.diariodarepublica.pt/2s/2019/12/241000000/0009100105.pdf</a>.

**Activity regime:** Awarding the grant does not create or establish a legal employment relationship. The activities will be carried out on an exclusive dedication basis. The grant holder status will be assigned in accordance with the Research Grant Holder Statute and the Regulation of Research Fellowships of FCT, I.P., both in their current wording.

Workplace: The work will be carried out at the UICISA: E, in Campus C of the ESEnfC, in Coimbra.

**Grant duration:** The fellowship will last for 12 months, on an exclusive dedication basis, and is expected to start in December 2024.

**Renewal:** Having regard to paragraph 3(e) of Article 7 of the Regulation of Research Fellowships of the FCT, I.P., it is possibly renewable for an equal period, up to a maximum of 36 months.

**Financial conditions of the fellowship:** The grant amount is € 1.801,00, which corresponds to the monthly maintenance stipends for FCT fellowships (<a href="https://www.fct.pt/wp-content/uploads/2024/02/Tabela-de-Valores-SMM atualizacao-2024.pdf">https://www.fct.pt/wp-content/uploads/2024/02/Tabela-de-Valores-SMM atualizacao-2024.pdf</a>).

This monthly stipend will be paid by bank transfer at the end of the month. (The Voluntary Social Security corresponding to the first level of the scale of contributions will be added to this amount if the grant holder chooses to receive it, as well as the personal accident insurance).

Selection methods: The selection methods will be as follows (see attached grid):

**Curriculum evaluation:** Curriculum evaluation is calculated using the following formula: AC = (10%\*HA) + (90%\*EP) where: **AC** - *Avaliação curricular* (Curriculum Evaluation), **HA** - *Habilitações Académicas* (Academic Qualifications), **EP** - *Experiência Profissional* (Professional Experience). Candidates will be ranked on a scale from 0 to 20 points.

The jury reserves the right to request additional information from the candidates about the submitted curricular information.

If none of the candidates has the right profile (overall evaluation below 50%), the fellowship will not be awarded.

Application procedure: Applications must include the following documents: Curriculum Vitae (organized as follows: 1 - Biographical data; 2 - Academic and professional qualifications; 3 - Professional experience, 3.1 - Scientific publications, 3.2 - Actions to disseminate science and technology, 3.3 - Participation in R&D projects, 3.4 - Other relevant professional activities); Motivation letter; documents attesting the qualifications with the final grade (or other proof of classification); and other relevant supporting documents, namely attesting English language proficiency, the candidate's statement under oath indicating the type of grants they were awarded and their duration. Applicants with academic degrees obtained abroad must present a Certificate of Recognition in accordance with the legislation in force (Decree-Law no. 66/2018, published in *Diário da República*, 1st series, no. 157, of 16 August). This document is required only at the contracting stage.

All documents listed above must be sent in PDF format. Applications submitted by other means (e.g., delivered by hand, sent by postal mail, etc.) will not be accepted.

deadline for application submission. The final evaluation results will be published in a ranked list on the ESEnfC website

prior hearing within ten working days after the final results have been announced.

Once the selection process has been completed, the fellowship contract will be drawn up using the FCT template.

At the end of the contracted period, the grant holder and the supervisor must draw up the final report based on the

established evaluation criteria.

Selection reserve: The ESEnfC reserves the right to call on unsuccessful candidates, by ranking order, to recruit any

additional grant holders necessary for the same project within 12 of notification of the final ranking list to the candidates.

If the selected candidate is unable to meet the conditions required to take up their post within one month of notification

of the final ranking list, the ESEnfC reserves the right to cancel the call (in the case of a single candidate) or to call upon

the next candidate to fill the vacancy.
